The City of Bay St. Louis has no liability under any theory of law for permitting Golf Carts to be operated on City streets or roads. Golf Carts and low-speed vehicles, as defined in Senate Bill 3026 are only permitted to be operated on roads within the City's municipal boundaries, except for prohibited streets.
