The meeting of the Bay St. Louis Municipal Harbor Commission convened at 3:00 p.m.

The meeting was called to order by Commissioner Seal.

Minutes - February 18, 2014

Minutes from the February 18^{th} Harbor Commission meeting were withheld until the next scheduled meeting.

Guest: Jason Chiniche RE: Harbor Update

Jason presented the Harbor Commission with preliminary sign designs and locations for signage at the Harbor and Rutherford Pier for discussion.

Reports

Commissioner LaFleur reported that representatives from product suppliers requested to attend the next meeting to let the commission know about their products.

The Tourism Bureau and Commissioner LaFleur will have an information booth at the New Orleans Boat Show on March 7^{th} thru 9^{th} .

Operating Budget

MOTION TO RECOMMEND APPROVAL OF AMENDMENT TO ORDINANCE NO. 547 RE: Lottery

Commissioner Compretta moved, seconded by Commissioner LaFleur, to recommend that the City Council approve an amendment to Section 37-18(b) of Ordinance No. 547 to read as follows:

"Berths or slips shall be assigned by order, *initially established by a lottery process and then by order* of application date, with property tax paying residents of the City of Bay St. Louis receiving first priority, followed thereafter by county residents then other residents of the state and then by all other applications."

Fuel Dock/Bait Shop RFP
