The meeting of the Bay St. Louis Municipal Harbor Commission convened at 3:00 p.m.

Jody Compretta Marina Resolution RE: Jody Compretta Dedication

Tish Williams, Chamber of Commerce Director and chamber board members, along with members of the Bay Area Recovery Team appeared before the Harbor Commission to present a resolution requesting that the Harbor Commission and City name the Marina inside the Bay St. Louis Municipal Harbor in memory of Joseph 'Jody' Compretta. Jody was a member of B.A.R.T., who was instrumental in the decision making and ground work to build a marina in the downtown district.

After a lengthy discussion was had on the matter, consensus of the Commission was to recommend approval of the resolution.

Harbor Master Report

Chuck Fortin reported that the soft opening of the harbor went exceptionally well over the weekend. Administration is in discussion of having a 24 hour security officer at the harbor. The harbor restrooms have to remain open to the public 24 hours.

Marketing Proposal

The Commission reviewed the marketing proposal submitted by The Focus Group. Consensus of the Commission was the price for services is too high. The Marketing Sub-Committee was asked to continue discussion with the agency to bring the price down.

New Business

The Commission discussed changing the meeting schedule to once a month having all needed documents in place, hiring of the harbor master and opening of the harbor.

The Commission will meet the third Tuesday of each month at 3pm. Special meetings require a one (1) day notice posted in two public locations.

The City Attorney reported that the Murphy's had been advised of the Commission's recommendation regarding their proposal for Fuel/Bait Shop Operation.

Rafferty advised the Commission there may be a potential ethics concern with Commissioners leasing slips. He's looking into the issue and will update the board further.
